1. Welcome and Opening Remarks

2. Review Minutes from October 4th, 2023, and Approve

3. Project List Update

1) CSA G401

- Meeting held on June 19th with quorum of members attending.
- 93 comments were received. Dispositioned, last meeting held on August 22nd with 15 members attending.

- Format was changed to product / profiles (CSP & SPCS) from current functions (Materials, Fabrication).
- Posted for public review on October 11th – December 10th
- Last step – break SPCS into SP, DC, TLP

- EPD meeting held with Stan Lipkowski (AMD) on July 5th.
- Meeting held with AGECO who will be performing the review. CSA will be the program operator.
- EPD manufacturer's data compiled and submitted to Stan Lipkowski (AMD) on August 31st.
- LCA report completed and sent to AGECO for critical review.
- Publication will be done by CSA.
- Signed agreement with Groupe AGECO on October 13th. They indicated 4 – 6 weeks to complete.

EPD's when published will not be posted to the public website, will be for members only until the next discussion takes place in March.

4. Member / Ongoing Items update

a) AMD – (Kamran)

b) Cleveland Cliffs – (Jim)

- Type II for SWM (Detention)
- Perforated Pipes – percolate on a stone base
- Overt issues (chlorides) – contamination of soil from salt above on pipes that were never protected is being looked at
- Solution is an easy one by using a membrane or plastic over the overt
- For SWM, design should include moving manholes off the lot onto grass where there is no salting

c) Valgroup – Lighter polymer laminate (Mike)

- Lighter polymer 5 mil, lighter galvanized 90G 100-year coatings to compete with small diameter concrete are now in ASTM A742. A929 to follow by end of 1st Q for 90G coating.
- Next step is to set up test sites in low abrasion areas.
- NCSPA will be putting together a promotional piece by April 2024

d) Leland - Bolt & Nut Research update (Byron / Dave)

e) Warner – alternative polymer coating update (Ian)

f) Ironside – machinery update (Derek)
